Stormy Weather, Sunny Skies Tell Our Story

A long, cold, stormy winter, and the sunny skies powering our Community Solar Garden are among the highlights of a productive year for your electric cooperative.

Our distribution system was hit by three separate, major storms – in November, at Christmas, and in April – and our teams responded quickly and safely to meet each challenge. For the latter two storms, which caused extensive damage over a large area, we also called on mutual aid from our neighboring co-ops to help us get the lines rebuilt as soon as possible.

Despite these storms, we came close to meeting our reliability goals. We continue to invest heavily each year in a long-term work plan that guides the maintenance and upgrading of our system. We have also focused on clearing rights-of-way, and completed a full cycle of reclaiming ground-to-sky clearance for our power lines. Our new focus will be on using modern clearing tools to keep those rights-of-way open.

Even with the costs of these investments, and the unbudgeted storms, our financial report (see pages 4-5) shows a strong year.

Not only did the board of directors authorize a retirement of \$1,340,000 in member equity as



capital credits in May, we believe this kind of performance will help keep your local rates stable. Member participation was above average, as well. You supported area food pantries as part of the Tri-County Electric People Fund's 20th anniversary in 2013, by bringing a ton of food donations to the annual district meetings. And, attendance was up at every district meeting this spring.

New initiatives during the year included phase 1 of our Community Solar Garden, a 20.9-kilowatt array of 76 panels at our Portland headquarters. Over one-third of the panels have already been leased by members, showing support for renewable energy.

We also started a member-owner program for the Action Committee for Rural Electrification (ACRE), which was met with strong support among delegates at the annual meeting in August. We took this appeal to district meetings in May, and plan to continue promoting it by encouraging members to add their voices as we speak with legislators and regulators in Lansing and Washington, D.C.

There are changes to come, of course. Long-time board member Laverne Hansen will retire at this year's annual meeting (read more on page 7).

Even the Farmer's Almanac can't tell us exactly what to expect in the way of future storms, but we believe HomeWorks Tri-County Electric is prepared to fulfill our mission of providing reliable, affordable electricity to improve the quality of life here in mid-Michigan.

Laverne Hansen Retires from Board of Directors

After 27 years of service to HomeWorks Tri-County Electric Cooperative as the voice of District 4 on the board of directors, Laverne Hansen has chosen to step down.

“Laverne has been involved with co-ops nearly all his life, so serving Tri-County Electric was a perfect fit for him,” says board chairman Carl Morton. “He’s been supportive of many major changes over the years, including the creation of a subsidiary for DirecTV and later, propane.

“More importantly, he has always been an advocate for work plans to improve our service reliability, and he encouraged member involvement at every opportunity,” Morton adds.

He grew up near Edmore, graduating from Edmore High School in 1956. He returned to Edmore after his Army service, and started his farm with 10 acres of kidney beans and an 8N Ford tractor. Since then he has grown kidney beans, corn and wheat, and now maintains about 1,000 acres of seed corn.

Laverne was first elected to the Tri-County Electric Cooperative board in 1987, taking the seat held by retiring director Keith Sackett, and represented HomeWorks on the Wolverine Power Cooperative board for 12 years.

He has been active in his community, with 35 years of service on his local church board, nine years on the county ag committee, eight years on the Michigan Bean Commission, and eight years on the Montcalm County Farm Bureau board, including four years as president.

He married Joyce in 1959; they have a son and a daughter, and two grandchildren.

SmartHub is an on-line service available through homeworks.org, or as a free app for iOS/Android smartphones and tablets. Combined with our automated metering system, SmartHub gives registered members daily data to review their energy use.

SmartHub also works as an easier way to contact HomeWorks Tri-County Electric in case of a power outage. Simply log-in and use the Service Status button to send a report directly to our Outage Management System.

You can include additional information, such as reporting a downed line, or even attach a photo to provide detail.
